

QUICK REFERENCE GUIDE:

DBE Commitments - Proposal

Background:

- This process is for internal staff who are adding or revising a DBE Commitment on behalf of a bidder when the project is in the proposal phase.
- This process is only for vendors that are currently loaded into AASHTOWare Project. If a vendor is not in the list of vendors, provide the vendor with a link to IRIS registration.
- Fields with red asterisks are required fields and must have data.

Add DBE Commitments on Proposal Vendor:

- 1. Click the **Row Actions Menu** for the appropriate vendor
- 2. Select Add DBE Commitments
- 3. Search and select the DBE firm
- 4. Enter a **Commitment Amount**
- 5. Enter a **Race Conscious Amount**
- 6. Enter a Race Neutral Amount
- 7. If applicable, type any **Comments**
- 8. In the **Component Actions Menu**, click **Save**
- 9. Repeat above steps as necessary for each DBE firm on the commitment

Revise Goals

- 1. At the **Proposal Vendor DBE Commitment Summary** Page under the upper Proposal Vendor component bar click the **Revised Goals** tab
- 2. Check the Revised Goal box
- 3. Enter the Revised Goal Percent
- 4. Search and select the individual for the **Revised Goal Approved By** field
- 5. Enter or select the Revised Goal Approved Date
- 6. If applicable, enter **Revised Goal Commitments**
- 7. Click Save

Add Good Faith Efforts to the Proposal Vendor

DBE Commitment Summary

- 1. At the **Proposal Vendor DBE Commitment Summary** page select the **Good Faith Effort** tab
- 2. Search and select the DBE firm listed for the contractor's **Good Faith Effort**
- 3. Enter any/all fields, as needed
- 4. Click Save
- 5. Click the **New** button for each DBE firm

Review and Approve DBE Commitments on

Proposal Vendor:

- 1. At the **Proposal Vendor DBE Commitment Summary** page under the lower Proposal Vendor component bar click the **Review** tab
- 2. Check the **Reviewed** box
- 3. In the **Reviewed By** field search and select the reviewer
- 4. Enter or select the **Review Date**
- 5. Click Save
- 6. Repeat 1-5 for all DBE firm commitments and scroll to the upper Proposal Vendor component bar and click the **Approval** tab
- 7. Check the DBE Commitment Approval box
- 8. Search and select the individual for the **Approved By** field
- 9. Enter or select the **Approval Date** field.
- 10. If applicable, indicate if the **Good Faith Effort** was **Compliant** or **Non-Compliant**
- 11. Click Save

Revise DBE Commitments on Proposal Vendor

- 1. At the **Proposal Vendor Summary** page, click the **Row Actions Menu** for appropriate vendor
- 2. Select Open DBE Commitments
- 3. At the **Proposal Vendor DBE Commitment Summary** page at the upper Proposal Vendor component bar click the **Approval** tab and uncheck the **DBE Commitment Approval** box.
- 4. Click Save
- 5. Under the lower Proposal Vendor component bar select the DBE firm for which the commitment will be revised
- 6. Click the **Revised Commitment** tab and enter a **Revised Commitment Amount**.
- If applicable, enter the Revised Race Conscious Amount, Revised Commitment Percent, and the Revised Race Neutral Amount
- 8. Click Save
- 9. Click the **Review** tab for that DBE firm and enter or select the **Revision Date**
- 10. Click Save
- 11. Scroll to the upper Proposal Vendor component bar and click the **Approval** tab
- 12. In the **Revised Commitment Approved By** field search and select the approver
- 13. Enter or select and enter the **Revised Commitment Approved Date**
- 14. Check the **DBE Commitment Approval** box
- 15. Click Save

Next Step:

If a revision to the DBE Commitment has been entered, reviewed, and approved it will be reflected on the General tab under the upper Proposal Vendor component bar. The Revised Commitment field will change to Yes.

The total revised amounts for any/all revised commitments can be viewed at the Revised Commitment tab under the upper Proposal Vendor component bar.

Once this proposal is awarded and transitioned to Construction (and CRL) you will not be able to make any further changes to the Proposal Vendor DBE Commitments.
