PURPOSE

This formalizes the policy and procedure (P&P) of the department on establishing procedures for communication between Statewide Aviation leasing section and other sections of the department ensuring that project work on state-owned/operated rural airports is conducted in accordance with department obligations under FAA Grant Assurances, while adhering to property management and maintenance and operations (M&O) requirements.

POLICY

It is the policy of the department that planning, design and construction (including right of way and environmental) and M&O sections have the responsibility for communicating with and including the Statewide Aviation leasing section in the planning and review of projects involving state-owned/operated rural airports.

PROCEDURE

- 1. Sections responsible for scoping, planning, designing or constructing, project work on state-owned/operated rural airports will provide the Statewide Aviation leasing section an opportunity to review and offer comments in all phases of the process.
 - M&O section will communicate with the Statewide Aviation leasing section on all actions affecting airport land management or tenant relations.
- 2. The Statewide Aviation leasing section review of state airport project work will include:
 - a. compliance with FAA Grant Assurances, as applicable

- b. conflicts with contractual obligations and rights under leases, permits, or other types of Statewide Aviation leasing section contracts
