How to Get your reimbursement...



Eligibility

To be eligible for reimbursement, you must:

- ◇ Be enrolled in an approved apprenticeship program
- ◇ Be working on an Alaska Department of Transportation & Public Facilities (ADOT & PF) project which has Federal Highway Administration (FHWA) assistance
- ◇ Women, minorities, or disadvantaged individuals

If you are unsure whether you meet the criteria above, please contact the Support Services office at the ADOT&PF Civil Rights Office. All contact information is listed on the back of this brochure.



Items Eligible

The following items are eligible for reimbursement:

- ◇ Training Materials and or directly related online coursework.
- ◇ Work Clothing and/or Tools-must be appropriate for your apprentice craft.
- ◇ Child care financial assistance is available. While working or involved in activities required to fulfill your apprenticeship program.
- ◇ Travel to a job site (airfare).
- ◇ Transportation
- ◇ Rent



Submitting Your Request

To request reimbursement you must:

- ◇ Complete a Reimbursement Assistance for Apprentices application form:
 - ◇ The application must be signed and include supporting documentation (i.e., paid invoice, bank statement, front and back of processed check).
- ◇ \$500 per year is the maximum amount to be reimbursed
- ◇ Location of forms:
