The Manager of the CRO reports to the Division Director, who has an established line of communication with and access to the Commissioner, in accordance with 23 CFR 200.9 (b)(1).

### WHY DID THE FEDERAL GOVERNMENT IMPLEMENT DBE PROGRAM?

### Background

The Department of Transportation (DOT) is dedicated to serving our community, including those businesses contracting with state agencies and recipients of DOT funds. The Department's Disadvantaged Business Enterprise (DBE) program is designed to remedy ongoing discrimination and the continuing effects of past discrimination in federally-assisted highway, transit, airport, and highway safety financial assistance transportation contracting markets nationwide. The primary remedial goal and objective of the DBE program is to level the playing field by providing small businesses owned and controlled by socially and economically disadvantaged individuals a fair opportunity to compete for federally funded transportation contracts.



DOT's Operating Administrations distribute substantial funds each year to finance construction projects initiated by state and local governments, public transit and airport agencies. DOT has the important responsibility of ensuring that firms competing for DOT-assisted contracts for these projects are not disadvantaged by unlawful discrimination. The Department's most important tool for meeting this requirement has been its DBE program, which originally began in 1980 as a minority/women's business enterprise program established by regulation under the authority of Title VI of the Civil Rights Act of 1964 and other nondiscrimination statutes that apply to DOT financial assistance programs.

The DBE program was reauthorized by Congress several times since its inception; most recently in the Infrastructure Investment and Jobs Act, <u>Pub. L. 117–58</u>, November 15, 2021, 135 Stat. <u>429 (23 U.S.C. 101</u> note), Also known as the Bipartisan Infrastructure Law (BIL). The Act describes Congress's findings regarding the continued need for the DBE program due to the discrimination and related barriers that pose significant obstacles for minority and women-owned businesses seeking federally-assisted surface transportation work.

To meet the stated <u>8 objectives</u> of the DBE Program Regulation, recipients of DOT funds must develop and implement a DBE program that conforms to DOT standards set forth in <u>49 CFR Part 23</u> (for airport concessionaires) and <u>49 CFR Part 26</u>. The integrity of DOT's DBE program depends upon systematic procedures to ensure that only bona fide small firms, owned and controlled by a socially and economically disadvantaged individual(s), are certified to participate as DBEs in DOT federally assisted programs. The DOT DBE Regulations 49 C.F.R. Part 23 and 49 C.F.R. Part 26 place primary responsibility for the certification process upon State Transportation Agencies.

# ALASKA CIVIL RIGHTS OFFICE DBE PROGRAM OVERVIEW

### The main objectives of the DBE Program are:

- To ensure that our contractors comply with DBE laws and requirements.
- To ensure that DBEs can compete fairly for federally funded transportation-related projects.
- To ensure that only eligible firms participate as DBEs.
- To assist DBE firms in competing outside the DBE Program.

### DBE applicants must meet these criteria:

- Business status, including size
- Social & economic disadvantage
- Ownership
- Independence
- Management and control

### **DBE Program Support Services:**

Support Services are available to certified DBE firms. These services are provided to improve and maintain the business capabilities of DBE businesses and to assist them to be more competitive in their work on FHWA-assisted projects.

To ensure that we can process your application as efficiently as possible, please provide the following:


- Documents outlining which charge you're interested in having reimbursed;

  - The supporting documents must include the business credit card statement which identify the account owner, financial institution name and logo.
- Financial documents submitted as supporting documentation, that contain other information that is not relevant to the requested reimbursement may be redacted and or removed at the applicant's discretion.

# NEW CHANGES & UPDATES TO THE DBE PROGRAM

### DID YOU PROVIDE COMMENTS FOR THE DBE/ACDBE NOTICE OF PROPOSED RULEMAKING?



As part of the Federal government's commitment to advancing equity and ensuring access to contracting opportunities, the Biden-Harris Administration and the U.S. Department of Transportation (USDOT) issued a Notice of Proposed Rulemaking (NPRM) to modernize the Disadvantaged Business Enterprise (DBE) and Airport Concession DBE (ACDBE) program regulations. The comment period was from July 21-October 31, 2022.

Some of the proposed updates to the DBE and ACDBE program regulations will include:

- Increasing the personal net worth (PNW) limit from \$1.32 million to \$1.6 million and excluding retirement assets from PNW calculations.
- Amending overly prescriptive ownership and control certification eligibility requirements.
- Simplifying the interstate certification process.
- Formally adopting COVID-19 flexibilities such as virtual on-site visits.
- Reducing reporting requirements for some Federal Transit Administration funding recipients.
- Empowering certified firms to better market themselves to prime contractors via expanded State directories.
- Helping more small businesses participate in Federal Aviation Administration-assisted airport projects by requiring airports to proactively remove obstacles and adopt more race-neutral strategies.
- Strengthening prompt payment monitoring and oversight requirements to help ensure that DBEs in all subcontracting tiers are promptly paid.

"These critical updates would help ensure that small and disadvantaged businesses continue to have a fair chance to compete for federally assisted contracts."

### What is the Bidder Registration?

All firms are required to submit a Bidder's Registration form before an Alaska Department of Transportation and Public Facilities (DOT&PF) project can be awarded. The Bidder Registration form must be submitted to the Civil Rights Officer (CRO) on an annual basis beginning January 1 and is valid thru December 31. Firms will be listed on the <u>bidder registration online directory</u>.

### What is a Contract Compliance Review (CCR)?

If a contractor is selected for the CCR, our office will provide written notification and forward the following documents: Initial Letter, CCR Checklist, Utilization Report, Sample Employee List, FHWA 1273, Women and Minority Organization List, Required Postings, Federal EEO Bid Condition. The onsite visit will be scheduled during the peak employment time, which holds the greatest potential for employment and promotion of minorities and woman.

### What is the 50% <u>DBE Reimbursement Form</u>?

Our offices invites DBEs to submit a reimbursement every Federal Fiscal Year of qualified purchases made by your business. Applications are processed on a first come, first served basis and are date stamped by the CRO. Please complete the application and submit the supporting documents.

### What is the Annual No Change Declaration Packet?

The purpose of the annual declaration is to verify your firm's continued eligibility in the program and identify changes that may affect Disadvantaged Business Enterprise (DBE) and Airport Disadvantaged Business Enterprise (ACDBE) certification. This information is required to maintain DBE/ACDBE certification with the Alaska Unified Certification Program (AUCP).


