Veterans Preference & Alaska Products Preference

Incorporate statewide special provisions ES19 (Highway) and A 18 (Airport) for state funded projects where no federal aid funding is involved and advertised after April 15, 2012 and use Form 25D-17 and Instructions for Alaska Produce Preference Worksheet.

Special Provision ES 19 replaces ES 09. Special Provision A 18 replaces A 3. They modify Section 103 (Highway) and Section 30 (Airports) Award and Execution of Contract to include Alaska Veteran's Preference and clarify Alaska Product Preference eligibility.

A new Form 25D-17, Alaska Veteran's Preference Affidavit, is added for proposers' verification of eligibility for veteran's preference.

The Instructions for the Alaska Products Preference Worksheet is revised to clarify the eligibility of an Alaska Product. The Alaska Products Preference Worksheet is not changed.
