AGENDA

Community Forum

The C&PTAB invited representatives from tribes, cities, organizations and the general public to the meeting to participate in an a.m. session specifically designed to: (a) learn about local experience, needs, successes and (b) solicit input to the C&PTAB draft strategic plan.

The Forum featured

- A presentation by Sam Thomas, Transportation and Infrastructure Specialist, Organized Village of Kasaan, who provided an overview of transportation efforts on Prince of Wales Island, and reviewed some of the challenges associated with coordinating public transportation. A copy of this presentation is included as Attachment A. Mr. Thomas also introduced one copy of the Island's transportation plan and coordinated public transportation plan.
- A panel discussion featuring the following individuals, who introduced themselves, their perspective, the state of coordinated transportation as they saw it from their perspective, predominant challenges and successes.

Following these presentations C&PTAB Chair Jeff Ottesen provided an overview of the role and responsibility of the C&PTAB, reviewing some of the background, data and lessons learned that inform the group's work. A copy of Mr. Ottesen's presentation is included as Attachment B. Mr. Ottesen discussed with the group the C&PTAB's need and interest in having them comment specifically on the draft C&PTAB strategic plan.

Participants were divided into three groups with a task to review the draft plan and respond to the following specific questions:

- 1. What questions or comments do you have about the desired future conditions?
- 2. How do the desired conditions support, or not, your experience and needs?
- 3. What are we missing?
- 4. What questions or comments do you have about the strategic direction?
- 5. Are there other things we should be working on over the next year or so to move toward the desired conditions?
- 6. Our action plan lays out the next six months of our work do you have any questions, comments or suggestions related to that near term work?
- 7. What other questions or suggestions do you have for us?

Lessons Learned

C&PTAB members, responsible for keeping their own notes throughout the morning session, participated in a lessons learned discussion to share and document those lessons. The facilitator documented their list of lessons learned on flip charts, and those notes have been transcribed and included in Attachment C.

Strategic Plan

Using the list of lessons learned and with some follow-on thought since the May 29, 2013 strategic planning session, the C&PTAB updated its strategic plan. The group confirmed the desired future conditions and strategic direction were consistent with and encompassed inputs provided at this meeting. The short-term action plan was modified to provide additional specificity. The group noted an appreciation for the document which is short, clear and specific. The updated version of the plan is included as Attachment D.

October Meeting / Transit Conference

The Facilitator reminded the group that it will be meeting on Monday, October 21, 2013 in Juneau - the day prior to the annual Alaska Community Transit Conference. Time on the Tuesday, October 22, 2013 agenda is available to the group to engage conference participants as appropriate and desired.

The Facilitator recorded on flip charts suggestions provided to that process, which have been transcribed and are included in Attachment C. Ultimately, the group acknowledged it must provide enough background information for conference participants to understand its purpose and responsibility without overwhelming participants with detail. The process proposal C&PTAB asked the Facilitator to develop includes:

1. An overview of purpose, responsibility and effort

- 2. A series of table top discussions, rotating by C&PTAB subcommittee, focused on subcommittee needs. Some may use tools for simple yes/no answers, and some may engage in more detailed discussions.
- 3. 10 tables 2 on each initiative, was recommended to allow for smaller work groups.
- 4. DOT&PF and C&PTAB staff and others will be secured to ensure two individuals are working each table.
- 5. Marsha will work directly with each subcommittee to design the table top discussions, process and documentation.

It is anticipated the group will need a minimum of 3 hours and potentially more to conduct this process. Marsha will work through the design and coordinate the details with Debbi Howard.

Annual Funding Review

Duane Mayes, Cheryl Walsh and Carol Wren met independently with the facilitator to review the Draft Annual Funding Review Report and discuss the scope and context of their respective pieces. Each took an action item to generate their entity's description and provide it in July to incorporate to the document.


- 1. Duane Mayes will provide a copy of the Medicaid Task Force Report to Marsha to send to the rest of the group.



Governor's Coordinated Transportation Task Force – Key Points

 At least one in nine Alaskans have special needs or circumstances that make them dependent upon public or community transportation services



- \$80 million spent annually across 21 federal and state programs on human services and public transportation – "silo effect" is alive and well
- + Non DOT programs lack incentives to coordinate
- + Statewide Vision and Action Plan featuring 8 Goals and a number of activities to achieve them

Governor's Coordinated Transportation Task Force – Lessons Learned

 Coordination is necessary at many levels (federal, tribal, state, local)



- Statewide interagency/tribal/stakeholder workgroup necessary, but must be active and effective
- The better data we can secure across agencies and organizations, the more effective our communication and likely our coordination opportunities
- + Our needs are greater than those your assessment reports
- + Action Plan is fine and good; must quit planning and start doing

Alaska Community and Public Transportation Advisory Board - Purpose



COMMUNITY AND PUBLIC TRANSPORTATION ADVISORY BOARD STRATEGIC ACTION PLAN JUNE 19, 2013 WORKING DRAFT

Purpose

In 2012, the Alaska State Legislature established the Community and Public Transportation Advisory Board (C&PTAB) within the Department of Transportation & Public Facilities (DOT&PF).

The C&PTAB is responsible for analyzing community and public transportation services in Alaska and making recommendations for improved agency coordination and combining of services to improve the effectiveness and efficiency of those services. The C&PTAB will prepare and implement a strategic plan outlining the mission, objectives, initiatives, and performance goals to pursue to achieve effective coordinated and community transportation (AS 44.42.095). In doing so, the C&PTAB will build upon the considerable work accomplished by the Governor's Coordinated Transportation Task Force (CTTF) from 2009 to 2012.

The C&PTAB consists of 13 members who serve at the pleasure of the Governor.

Scope

÷

The C&PTAB Strategic Plan presents C&PTAB's effort to secure effective coordinated community and public transportation systems in Alaska. It outlines the desired future conditions for the community and public transportation system it seeks to achieve, and presents the specific actions the C&PTAB is taking to get there. Addendum 1 provides the specific detail. Designed as a working document, the Strategic Plan will be reevaluated and revised at regular six month intervals. Completed activities are anticipated to result in products to effect coordination and specific recommendations for the Governor and the State Legislature to sustain it. Those recommendations will populate future versions of this Strategic Plan.

Involvement Opportunities

The C&PTAB meets three times per year in a different location in Alaska, and always in the third week of October at the Alaska Community Transit Conference. Modeled after a process initiated by the previous CTTF, each meeting typically features a location-specific public stakeholder forum featuring interaction among the board members and local participants. The Transit Conference typically features an interactive discussion among conference participants and the board, where the board seeks specific input on its draft products, insights on issues it is working or needs to work, and input specific to attendees interests. Of course, all individuals are welcome to attend C&PTAB meetings and opportunities for public comment are always provide.

Where We're Going - Desired Future Conditions

Over the next 3-5 years, the C&PTAB seeks to facilitate the development of a coordinated system that features the following desired future conditions:

- State agencies and tribes are employing measurements indicating the effective of transportation coordination and benefits (including economic development, services and funding). These measurements are trackable and data is used in a consistent fashion.
- State agencies, tribes and the veterans administration are actively breaking down barriers across programs to minimize costs and streamline services and state agency funding.
- Users have access to the most appropriate and efficient transportation to meet their needs, and measurements are in place that indicates appropriate accessibility.
- All local governments, tribes and applicants for any and all federal and state funds are mandated to respond to priorities established in their local coordinated public transit/human services transportation plans.
- Municipalities are addressing taxicab ordinances in a manner that fosters accessibility and safety for consumers.

How We're Going to Get There - Strategic Direction

The C&PTAB has identified a number of specific strategies to pursue in the interest of securing the stated desired future conditions. Over the next year or two, the C&PTAB will be

- 1. Developing common definitions, terminology and criteria to describe and depict coordinated community and public transportation.
- 2. Establishing grant and RFP conditions based on those criteria and used for funding transportation awards.
- 3. Exploring solutions used by other states and municipalities specific to taxi cab ordnances and Medicaid brokerages, identifying best practices and providing templates as appropriate for state and local use.
- 4. Establishing a state interagency work group as a subcommittee to the C&PTAB with which to consult and work on interagency-specific issues and barriers.
- 5. Educating a range of audiences about transportation options, it's relevance to a variety of individuals and stakeholder groups, the benefits coordination provides the state and the user, and the role coordination plays in the community and the state .
- 6. Preparing performance measures for tracking results specific to coordination activities and outcomes, including the work of the C&PTAB itself, the transit community as a whole (including transit providers and those who fund or provide transportation benefits) and the degree to which the system starts to address unmet needs.
- 7. Inventorying regulations and funding streams.
- 8. Establishing a Transportation Ombudsmen at the state level with the duty to coordinate and facilitate efforts across state agencies.
