 - a. An expansion of the landside seating area for Norton Sound Seafood House is anticipated to be completed by this fall. The area will include the sale of beer, wine and liquor.
 - b. Construction has begun on a new spa concession. The Northern Lights Spa will offer manicures, pedicures, massages, tanning, and hair styling.
- 5. LHD/Z41 Identifier Combination Effective October 17th, 2013, the FAA single identifier for all of Lake Hood (both lake and gravel strip) is "LHD". The gravel strip will no longer be separately identified as "Z41" and instead is "LHD RWY 14/32" (Note: the Lake Hood ICAO identifier remains PALH).
- 6. Lake Hood Tiedown Parking: storm drainage construction required temporary relocation of several tiedown users in Alpha, Bravo & Charlie General Aviation Parking. Work has been completed in Alpha and Bravo and is expected to be completed in Charlie by the end of October. Permittees are being allowed to return to their regular parking spaces as the spaces are returned to service.
